DESIGN THINKING FOR INNOVATION

STRATEGIC AGILITY

With an agile, prochange mindset, students learn the communication skills needed to deliver out-of-the-box solutions to unique enterprise problems.

BUSINESS ANALYTICS

In the Business Analytics Advanced Area, students acquire a strong understanding of the basic concepts of business analytics. Students will be exposed to a comprehensive overview of the field of business analytics, including data mining, statistical modeling, media analytics and more.

GLOBAL BUSINESS

REDUCING THE COST OF YOUR DEGREE

Nexus University has several options for reducing the cost of your education. These include different types of scholarships, transfer credits and optional monthly payments. Our monthly payment plan is a private education loan with 0% fixed interest (0% APR) and no money down, with payments from just \$250/month.

Not everyone will be eligible for cost-reduction options, so please contact an admissions representative to discuss your questions and see if you qualify.



* Reduced Installment Plan: The student can opt to pay a \$250 interest-free monthly payment based on the program of choosing; when applicable (depending on duration of the program), the monthly payment will increase 20% yearly. The student can elect to pay more when possible. The student must pay the total program commitment before graduation. No additional fees apply.

DEGREE CURRICULUM – 2021-2022 SCHOOL YEAR

ADMISSIONS REQUIREMENTS

- 1. A bachelor's degree from an accredited institution recognized by the USDOE or a bachelor's degree from approved international university with at least a 2.0 cumulative grade point average (GPA).
- 2. International degree plans must be evaluated by a member of the National Association of Credential Evaluation Services (NACES).
- 3. Students must submit current government issued identification.
- 4. Students must reside in the State of Florida or student living in a foreign country (not approved for I-20 Visa students). (This is an online program only.)
- 5. Submit application with \$25 fee.
- 6. Original transcripts must be sent directly to the Registrar at Nexus University and be appropriately signed and sealed or securely emailed to the Registrar at registrar@nexusuniversity. com.
- 7. Students who earn their bachelors in a language other than English and have not earned at least 30 college credits in the U.S, are required to sit and submit official TOEFL (Test of English as a Foreign Language) or IELTS (International English Language Testing System) results:
 - a. TOEFL Must score a minimum of 70 on the IBT (Internet Based test).
 - b. IELTS Must score 6.5 or better overall.
 - c. Nexus University code is 4237

ADMISSIONS PROCESS

- 1. Complete the Nexus University application.
- 2. Submit with non-refundable application fee.
- 3. Submit Official Transcripts from all higher education institutions.
- 4. Be accepted as a student by Nexus University..

DEGREE REQUIREMENTS

Students must complete the MBA with the core courses (30 credits) plus two approved specialization courses (6 credits) from the advanced study areas, for a total of 36 graduate semester credit hours.

Completion of a general examination the semester the student will graduate. This is a comprehensive examination that is administered during the final semester of enrollment after successful completion of the required core coursework. The examination's main purpose is to assess student learning as it relates to the program learning objectives.

A full-time student may complete the MBA program in 12 months.

Courses in the MBA program are eight-weeks in length, and students may be scheduled for one or two courses concurrently.

To receive a Master of Business Administration degree, students must earn 36 graduate semester level credit hours. A minimum of at least 30 of the program hours must be completed at Nexus University.
